PYRAMID LAKE FISHING GUIDE PERMIT AND BOAT CHARTER APPLICATION

<u>Attention:</u> The following will apply without exception.

- 1. All applicable sections of the fishing guide permit boat charter application must be complete and legible prior to validation. No "pending", "unknown" or blanks will be accepted.
- 2. Incomplete permit applications will be returned resulting in a processing delay.
- 3. A signature is required.
- 4. A fishing guide permit will be mailed within seven days of application approval after the first Tribal Council meeting in August.
- 5. All Guide Permits will be valid for the fishing season running October 1 through September 30 of the year for which permitted.
- 6. Fee for both fishing guide and boat charters is \$7,500 each per year.

Important Notice to Guides

Pyramid Lake Paiute Tribal Regulations Brochure (Section 21) requires that all licensed guides providing fishing guide services at Pyramid Lake must apply annually for a permit with the Pyramid Lake Paiute Tribe <u>before</u> guiding activities begin. The fishing guide permit application must be completed, signed, and dated by the guide applicant and submitted, with fee, a copy of the insurance certificate, and other applicable certificates for approval no later than July 30, 2021. <u>Guides hired by a charter operator must keep the validated permit in their possession while guiding. There are no subguides, all guides MUST have a valid Pyramid Lake Fishing Guide Permit.</u>

A fishing guide/boat charter should be able to present all documents required for the permit upon request by a representative of the Tribal Ranger department or Tribal police officer. While engaged in providing fishing guide services, a guide shall have the following readily available for inspection:

- A current Pyramid Lake Paiute Tribe (PLPT) Fishing Guide/Boat Charter Permit which has an embossed PLPT stamp
- A valid photo identification card.
