Pyramid Lake is Open for Memorial Day 2021!

Fireworks sold at all three Store locations; permits sold online and at Ranger Station in Sutcliffe

Nixon – The Pyramid Lake Paiute Tribe is opening all beaches just in time for Memorial Day 2021. There are no more limits to campers on the beach. Please be aware that there are still restricted areas, such as the Pyramid, Anaho Island, Howard and Dago Bay, the Needles; these areas are still closed to the public. Permits are *only* available through these options: online at <https://plpt.nagfa.net/online/> or the Ranger Station from 8:00 am to 4:30 pm throughout the weekend. Seasonal Day Passes have now been added for Seniors over 65 years of age. *Please be patient; the workers are doing their best.*

Fireworks and Fireworks permits are also available at our three stores: I80 Smokeshop, The Nixon Store, and the Marina. Check out their website at <https://www.i80casesales.com/> All fireworks purchases are on a first come first serve basis; *no holds*. Must have fireworks permit at all times while at designated beaches. Your Fireworks Permit is valid from dusk to midnight; if visiting the lake before or after these times, a Pyramid Lake Day Use and/or Camping permit is required for purchase.

Face masks are required at all store locations; masks must cover nose.

The Nixon Store will be closed June 6/1-6/3/21 for gas pump replacement; please gas up at our other locations before then!

You can also check out the Pyramid Lake Museum and Visitor's Center in Nixon, which is opened Monday – Saturday from 10:00 to 4:30 pm. Masks are *required* for entry; please see our website at pyramidlake.us for complete COVID 19 safety regulations.

Above all: ***if you pack it in, PLEASE PACK IT BACK OUT!*** Help keep the beaches clean by cleaning up after yourself.

Summary of the Pyramid Lake War of 1860

On this day in 1860, the first of two battles of Pyramid Lake took place in present day Nixon. The accounts report that the soldiers reached Nixon at approximately 3:00 PM and the battle begun at about 4:00 PM and lasted approximately two hours. Below is a historical timeline I wrote back in 1999. I used this format as it was similar to the state's chronological history of the Truckee River.

May, 1860: Notices are posted noting the land as the Indian reservation. 87¹

May 7, 1860: Mogoannoga, chief of the Humboldt Meadows band, known to settlers as Captain Soo, stole away from the council seven braves and attack Williams Station,⁸⁸ ²(near present-day Silver Springs) and rescue two young Paiute women held captive. All five white settlers are killed in the raid. 89³

May 10, 1860: 105 poorly armed, ill-disciplined detachment of men, under the command of Major William Ormsby depart Virginia City, Silver City, Carson City, and Genoa en route to Pyramid Lake. 90⁴

May 12, 1860: The first battle of Pyramid Lake takes place along the Truckee River (near present-day Nixon). 91⁵ It is reported Major Ormsby and seventy-five(75) of his men are accounted as killed. It is accounted more of a slaughter than a battle. 92⁶

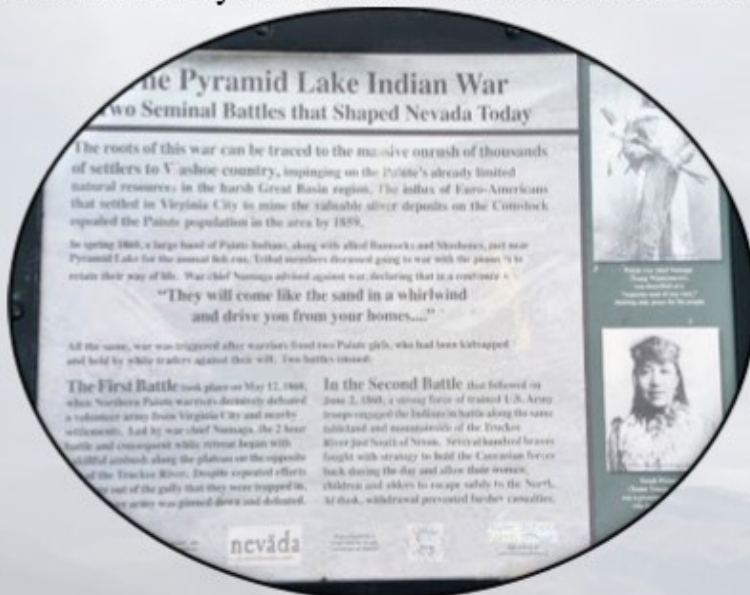
May 24, 1860: 800 well-armed and better-led men leave Virginia City en route to Pyramid Lake as a result of the first battle. 93⁷ The majority of these soldiers are dispatched from Sacramento.

June 2, 1860: The second battle of Pyramid Lake takes place in the same area as the first battle. Due to the higher fire power of the white soldiers, the Paiute slowly withdraw to the north 94⁸ and do not suffer high casualties. The Pyramid Lake War is proved a draw. 95⁹

August 9, 1860: Indian Agent Dodge writes to the Commissioner of Indian Affairs, "Trespass and depredations of every kind have been committed on these Indians [Pyramid Lake Paiutes]." 96¹⁰

Dear Pyramid Lake Community and Tribal Employees,


As the Pyramid Lake Paiute Tribe moves forward during the COVID-19 Global Pandemic and as we continue to vaccinate our community members, plans for safe reopening must focus on how we can continue to mitigate the spread of Covid, protecting and recovering our communities. Our Covid-19 vaccination count is at "758" which means 60% of our community members are vaccinated, we still have 40% that have not received the vaccination at this time. Our Covid cases are up and down, we are also finding that our children are contracting Covid. We are currently at "7" active Covid cases, that is something that we are happy to report as it is through our hard work, compliance as a community and our Tribal Council, Administration and Health Clinic in mitigating the safety measures that we have finally reached this point. We still must recognize that there are still other Covid variants that are being reported in communities nearby.

In light of the State of Nevada adopting the updated CDC Mask Guidance, the Pyramid Lake Tribe will follow the safety measures listed below. In doing this we are protecting the unprotected, those who have not been vaccinated. We encourage those who have not been vaccinated to be vaccinated, this also protects you and our community members. This is still the best way to protect our community members until more of our members are vaccinated, this includes:

- ✓ Requiring the use of masks
- ✓ Social distancing of a least 3 feet
- ✓ Limiting the number of people in enclosed spaces
- ✓ Increasing ventilation
- ✓ Cleaning and disinfecting high-touch surface constantly
- ✓ Continuously washing and sanitizing your hands
- ✓ If you are sick, stay home

Each safety measure reduces overall risk and combining all of these measures have proven to be the most effective, with that being said we must continue to encourage the safety measures. The Pyramid Lake Paiute Tribe continue to assess the risk associated with specific activities and will work with all to mitigate the spread and decrease community transmission. We will still continue to require masks in our Tribal Offices and places of business.

We will continue to focus on opening our community safely and planning for the future. Please continue to be safe. We want to come back together as a community safely and we will. Take care.

The Pyramid Lake Museum has several displays in the works including the Pyramid Lake Paiute Tribe/Reservation, Cultural Survival, Impacts of Covid-19 at Pyramid Lake, Dodge Flats Solar Farm, Bighorn Sheep Reintroduction, MMIW, Pyramid Lake Wars of 1860, Reno Rodeo/Parade and Truckee River Clean-Up. It's an exciting time to highlight the tribe's current events and history. So far, there's been collaborations with the Language and Cultural Program, Health Clinic, Emergency Response, Natural Resources, Victim Services, and PLAN Nevada.

In June, Levi Frazier, Sr., will be inducted into the Reno Rodeo Hall of Fame. Levi was a renowned tribal member and Champion Calf Roper, Team Roper and horse trainer. The honoring of our Paiute people is well deserved and something to be proud of. Another display to be worked on for our Native cowboys and cowgirls.

~ UPDATE FROM THE PYRAMID LAKE MUSEUM AND VISITOR'S CENTER ~

We had a very successful and powerful day for the National Day of Awareness for Missing and Murdered Indigenous Women (MMIW). A lot of information, prayers, songs and dances were shared to honor the lives of MMIW and to show that they are not forgotten. The MMIW exhibit will be displayed during the month of May. It's good to see that other tribal departments, such as the Health Clinic, Fisheries and High School showed their support by wearing red. As most may be aware, President Biden declared May 5th as the National Day of Awareness for Missing and Murdered Indigenous Women. This is an important issue that needs to be addressed at all levels. Under the new leadership and with Deb Haaland as the Secretary of the Interior there will be more funding and attention to help stop the violence against Indigenous people.

As we were reminded on Wednesday, this is not a new issue for the Numu Kooyoee Tukadu, Pyramid Lake Paiutes. The Pyramid Lake Wars of 1860 were started because of the abduction of 2 young Numu girls who were sexually abused and hidden away. After the battles in 1860, Numu women, children and elders went north to Mud (Winnemucca) Lake to set up camps. In March of 1865, there was a massacre at Mud (Winnemucca) Lake killing women, children and elders while the men from the 1st Nevada Volunteer Cavalry Battalion originally looked for cattle thieves, who were most likely Smoke Creek Paiutes. Instead, 32 Paiutes were killed and only 2 of those were men. This horrific incident was named as a "skirmish." In 1879, over 2,000 Paiutes were force marched to Fort Simco (Yakama) in the middle of winter and many perished in the freezing weather. This is not a pleasant history, but these stories need to be told so our people can heal and our current and upcoming generations understand the historical trauma that underlies violence against indigenous people.

Healthy Coping strategies along with social support can help a person feel that they are not alone.

Healthy coping means having a positive

attitude towards managing a condition and positive relationships with others.

It's important to find healthy ways to cope so you don't turn to harmful habits such as smoking, drugs, overeating, or alcohol. This is especially true if you have diabetes. Having a lot of stress can increase your blood sugar levels, making you feel more negative and may lead to less healthy choices.

There are many healthy ways to cope with stress. The most important thing to remember is that help is available. Your diabetes care and education specialist,

your provider, and your support systems such as your family and friends are there for you. They can help you problem solve self-care issues you are having, in order to lower your stress and improve your ability to cope.

Everyone has good days and bad days. It's normal to feel discouraged or frustrated from time to time. Sometimes, however, the stress or overwhelming feelings you're having are a sign of something bigger. It's helpful to talk to your health care team.

- The District offers four consecutive weeks of summer learning for all students Kindergarten through 12th starting on June 22 through July 15, 2021.
- Each week on Tuesday, Wednesday, and Thursday, students can attend summer school at their zoned school or work independently using virtual learning resources.
- The summer programs will be socially and academically specific for grade levels.

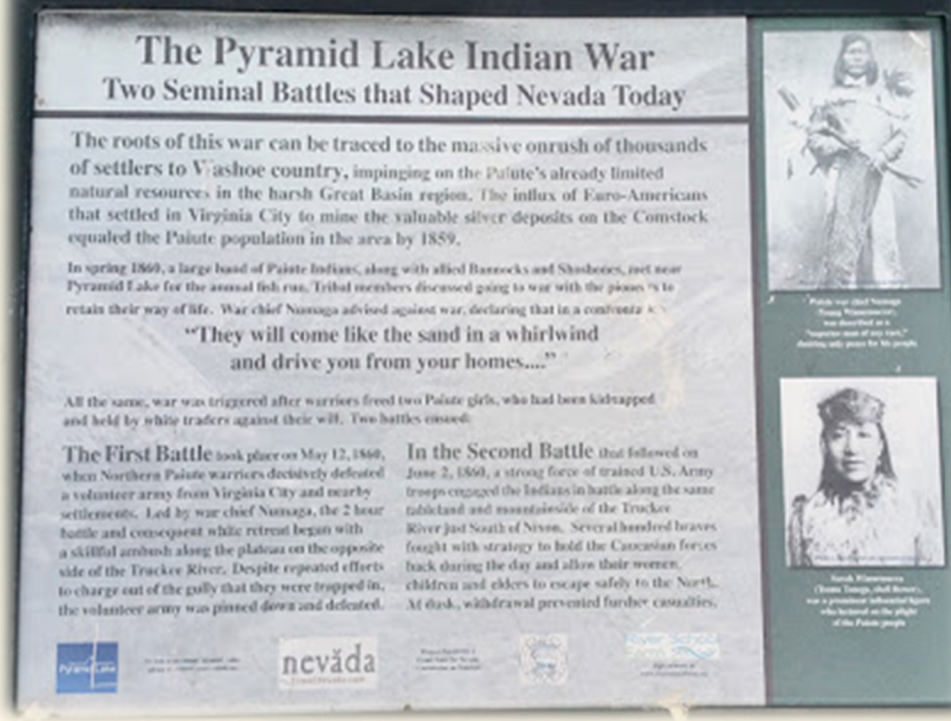

2nd Quarter Minor's Distribution Deadline is June 30th!

If you are age 18 by June 30, 2021, then you are eligible to receive your payment from the Minors' Trust. Please do not submit early to expect an earlier distribution before your birthday – all Minors' applications will be held and submitted upon the indicated Quarterly Deadline. This application must include an updated address with our Enrollment Officer, Joanne Shaw, a clear scanned copy of your Photo ID and a deposit slip from your bank with ACH wire transfer number and account number. The routing number must match the one on a check or direct bank form (you may download a form from the PLPT website or acquire one from your bank as well) – do not submit a generic deposit ticket; this can cause delays with your deposit. Please include CLEAR and LEGIBLE contact information in case you need to be reached! If there are any questions from the Pyramid Lake Paiute Tribe staff that are processing your paperwork, PLEASE leave a distinguishable email address and make sure that your voicemail box is set up in the event that we have to leave a message in order to get a hold of you. The tax information brackets on top of the second page MUST be completed, or this will cause a delay in your payment. If delayed, your application won't be processed in time and you will have to wait until the next quarter to receive your funds. The 2nd Quarter deadline for year 2021 will be June 30, 2021, and any late applications will be sent then.

Once your application is processed, you can expect a 2-3 month wait until your funds are distributed – the Tribe is responsible for verifying your information and submitting your forms. Because Minors' funds are in a trust, please understand that this quarterly process is because funds are calculated by the length of time it has gathered interest sitting in that trust; it is NOT distributed like the Adults'.

Minors will have up to six years to complete their forms and claim their economic stimulus payment. The six-year count starts on your 18th birthday.

Reminder that the deadline to submit your forms for this 2nd Quarter of 2021 is on the last Wednesday of June 2021. Applications received by 06/31/2021 will be processed and forwarded to the Trust the next business day. Applications received after 06/31/2021 will be held until the next quarter submission, which is September 30, 2021. Reminder, it is your responsibility to ensure that your form is received COMPLETE and date-stamped by June 30, 2021.
