**This is for the upcoming 2019 Fourth Quarter Minor's Distribution**

**Deadline:**

## **FACT SHEET FOR MINOR'S DISTRIBUTION**

- 1. Funds will be received at least 2-3 months **after** deadline. Please plan accordingly.**
- 2. All Minors' Applications are processed at the same time – turning in a form earlier than the deadline doesn't ensure a faster result.**
- 3. The whole process goes from receiving and verifying your information with our PLPT Enrollment office, which includes verifying Enrollment numbers, social security numbers and updated addresses. The paperwork is then submitted immediately to the Trust Company, which is then processed there for at least a month. The Trust Company then submits their completed forms to the Bank, and after verification with the bank, your money will **THEN** be distributed – this sometimes takes up to 2-3 MONTHS. Please plan accordingly, and expect that your money will arrive 2-3 MONTHS after the Quarter Deadline.**
- 4. The Trust company will contact the PLPT office for more information according to their standards – your contact information needs to be legible just in case we need to reach you. If you can't be reached, your form will be held until you contact us.**

## Minor's Distribution Information:

If you are age 18 or more by December 31, 2019, then you are eligible to receive your payment from the Minors Trust upon completion of distribution paperwork. Forms cannot be turned in early for "early processing", as all Minors' forms are processed quarterly, at the same time. Please make sure that your mailing address is up to date with the Enrollment office, that you include bank verification (including routing and account numbers, or a voided check – do NOT include a deposit ticket, as this does not include the necessary information), a clear copy of your picture ID included, and the second page marked and signed. The tax information brackets on top of the second page MUST be completed, or this will cause a delay in your payment. Please include CLEAR and LEGIBLE contact information in case you need to be reached!

If your forms are not turned into the Pyramid Lake Paiute Tribe until after the quarter ends, then your form will be held until the **next** quarter. Minors who have an account in the Minors Trust but are not able to return their forms timely will have up to six years to complete their forms and claim their economic stimulus payment. The six year deadline starts on your 18th birthday.

This is a reminder that the deadline for you to submit your forms for this 4th quarter of 2019 is on the last Tuesday of **December 31, 2019**. Forms are available in the Enrollment Office and online at: <http://plpt.nsn.us/>

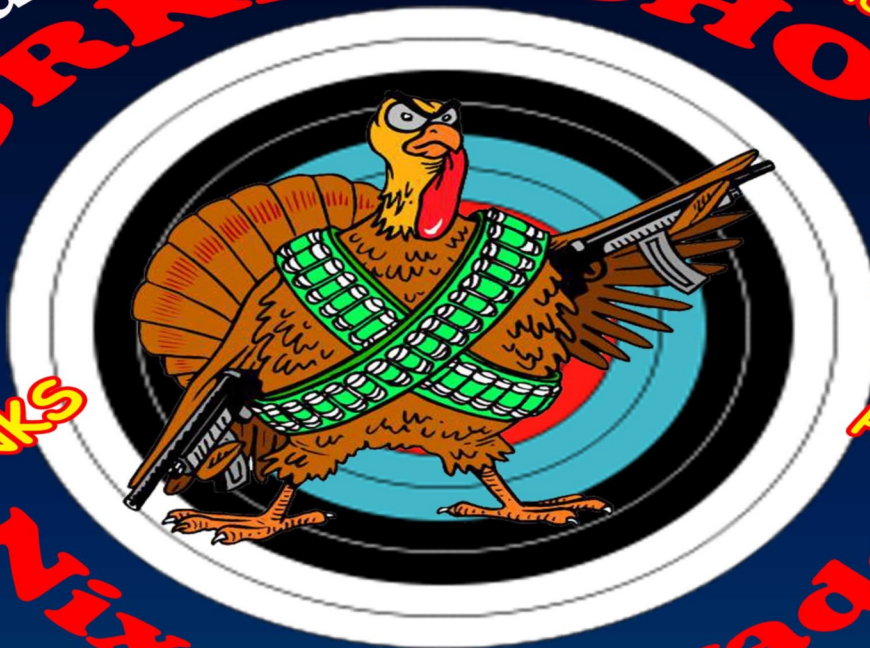





## 2019-2020 Trout Fishing Opens Oct. 1st!

The abundant snowpack over 2019 allowed much needed attraction flows for spawning Pyramid Lake Fish. Approximately 2,000 mature Lahontan Cutthroat Trout were released to spawn naturally into the Truckee River this past spring. The Pyramid Lake Fisheries staff also obtained 1 million eggs from this Spring's spawning events, resulting in 550,000 Lahontan Cutthroat Trout. The Staff at Numana Hatchery also released 115,000 small fry into the lower Truckee River in June.

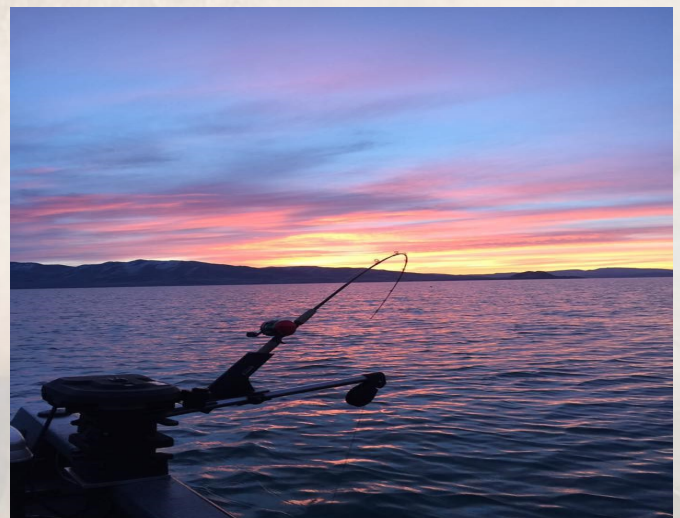
Help Stop the Spread of Aquatic Hitchhikers...Clean, Drain, Dry! Aquatic Invasive Species (AIS) means any species not already native to the waters of the Pyramid Lake Paiute Reservation whose introduction to those waters is likely to cause economic or environmental harm, or harm to human health. Aquatic Invasive Species pose a serious threat to the waters to the Truckee River-Pyramid Lake Region, and could have a disastrous impact on the ecology, infrastructure, recreation and economy of the Tribe. AIS threatens the health of our fisheries and aquatic ecosystem.

All watercraft, fishing equipment, and recreational gear that touch the water can pick up AIS. AIS are highly adaptable and can tolerate a wide range of environmental conditions. Once established, AIS are extremely difficult and costly to control or eradicate. Remove (Clean) all plant and animal material, mud and debris from the watercraft, trailer and boat

equipment (anchors, buoys, etc.) Pull all plugs and Drain all residual water from inside the vessel including compartments, live-wells, ballast tanks, bilge areas, freshwater cooling-systems, lower outboard units, buckets, etc. Allow proper time for the vessel and boat equipment to completed Dry. Any standing water or wet gear has the potential to harbor AIS.

The Creel census station will be open every weekend near the old Pyramid Lake store on highway 445. Fishermen can also voluntarily stop and fill out a questionnaire at the Creel census station near the Nixon Store, which is open 7 days/week.

## Pyramid Lake Fisheries 2019 Spring - Summer Report

Pyramid Lake Fisheries staff obtained pounds, were released to spawn naturally—approximately 1 million eggs from this rally into the Truckee river this past Spring's spawning events, resulting in approximately 550,000 Lahontan Cutthroat trout. To prevent overcrowding at Numana hatchery, staff released approximately 115,000 small fry into the lower Truckee River in June.

Special thanks to all the Tribal departments (Clinic, Diabetes, PL /Jr/Sr High School, Natchez, Numaga, Housing, Environmental, EMS and especially Lake Maintenance). Sorry if I missed any. Joseph Lent from the Bridgeport Colony offered a welcome prayer and pine nut songs and the US Forest Service provided fire safety and a bag of goodies to the students. The clinic also provided t-shirts to the

students. We had over 150 people out gathering, it was a sight to see! 100 of "pickers" were students from PLHS and 4th & 5th graders from Natchez Elementary School. This event is done for the Elders and is to ensure that our traditions and culture continues. With the youth participating we are able to stress the importance of taking care of our Elders, each other (cooperation and watching out for each other), outdoor safety, and hearing some stories and songs of our culture directly related to pine nut picking. We were able to gather quite a bit and still have a lot of work yet to get them cleaned. All the participants will be able to share a little bit, but most will go to our Elders (especially those that are homebound). I encourage everyone to head out to the mountains and pick as there are a lot of pinenuts this year.

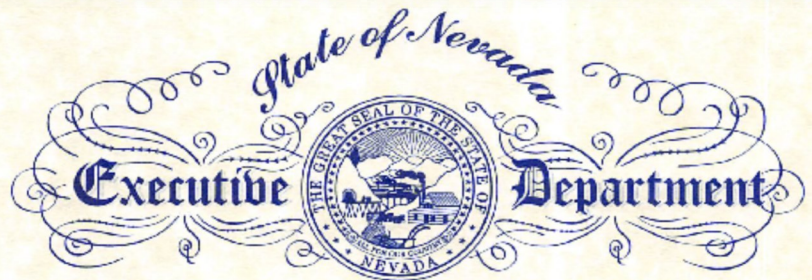

## Governor Sisolak's proclamation for Native American Day, September 27, 2019.

**“The great State of Nevada recognizes the outstanding contributions of Native Americans, commemorates their achievements and encourages all Nevadans, and those who visit our great state, to learn about Native American Heritage, culture, and history by visiting the Stewart Indian School Cultural Center and Museum in December, 2019.”**



### *A Proclamation by the Governor*

*WHEREAS*, Native Americans are the original inhabitants of the territories that now constitute the United States of America; and

*WHEREAS*, the Silver State is home to the Great Basin Native American tribes, the Washoe, Northern Paiute, Southern Paiute and Western Shoshone, which encompass 27 Tribes, Bands and Colonies, each having unique traditions and identities spanning generations; and

*WHEREAS*, American Indians in Nevada and nationwide have made invaluable contributions to our nation, including their role as the first keepers of our environment; and

*WHEREAS*, Indian tribes in the State of Nevada work to maintain their dynamic culture, customs and traditions in order to pass them on to future generations; and

*WHEREAS*, indigenous tribes across our state played an important role in Nevada's statehood, becoming residents of the Silver State in 1864, before officially becoming U.S. citizens 60 years later; and

*WHEREAS*, Nevada's Indian tribes have enriched the citizens of the Silver State by teaching and sharing their history, language and culture through storytelling, dance, native regalia, art, and traditional foods; and

*WHEREAS*, the great State of Nevada recognizes the outstanding contributions of Native Americans, commemorates their achievements and encourages all Nevadans, and those who visit our great state, to learn about the Native American heritage, culture, and history by visiting the Stewart Indian School Cultural Center and Museum opening in December;

**NOW, THEREFORE, I, STEVE SISOLAK, GOVERNOR OF THE STATE OF NEVADA**, do hereby proclaim September 28, 2019, as

**NATIVE AMERICAN DAY IN NEVADA**
