**TITLE: PLPT Data Center Server System** 

The Pyramid Lake Paiute Tribe (PLPT) is soliciting quotes from qualified vendors for the data center server system. There are three primary options for quotes. The first is an integrated and fully redundant compute node system which is a COTS system comprised of data storage, compute nodes, switching, software, licenses, VM solution and management system. The second is a hybrid fully redundant compute node system. This will be comprised of the same options with the exception of not being a COTS solution. The third option is for a rack server array solution with fully redundant independent servers, operating system software and licenses. Specifications for quoting are minimum, and options for upgrading individual components are acceptable. Please specify if any software and licenses are not included in the quote. It is ideal that software licenses be of 3 year duration if possible. Value added services and support contracts are important options for consideration. # **Location Description**

The equipment will be housed in a new pre-fabbed network node building. There is 200 amp service of redundant power, both 48 volts and 120 volts. Backup power and climate control are also in the node. **The entrance to the** 

**node is a single 36 inch door with an actual opening of 34 inches.** So it is imperative that all solutions are specified with overall dimension requirements. If this affects a pre-built solution and there is an alternative to installation, then please duly note this. There will be a 10 GB and 1 GB drop for the server system.
