**Family Policy Compliance Office (FPCO) Home**

**The Family Educational Rights and Privacy Act (FERPA) (20 U.S.C. § 1232g; 34 CFR Part 99) is a Federal law that protects the privacy of student education records. The law applies to all schools that receive funds under an applicable program of the U.S. Department of Education.**

**FERPA gives parents certain rights with respect to their children's education records. These rights transfer to the student when he or she reaches the age of 18 or attends a school beyond the high school level. Students to whom the rights have transferred are "eligible students."**

**What is it that our Consolidated Higher Education Program wants to accomplish!**

- **Career Counseling**, to assist the High School Guidance Counselor in providing information in any career opportunity that a student is interested in or pursuing.
- **Scheduling Student and Parent Workshops**, on subject matter to help student(s) in maneuvering thru their high school years and on into College or an Adult Vocational Training Institution.
- **Inform our Tribal high school students on how to apply for our Pyramid Lake Paiute Tribal Scholarships**; along with providing other information on how to apply for other scholarships that may pertain to the career goals.
